Dear Colleagues.

The International Committee for Study of Bauxite, Alumina & Aluminium (ICSOBA) has great honour in announcing: The International Seminar on Bauxite Residue (Red Mud) to be held in Goa, India during October 17-19, 2011.

In the span of last 48 years, ICSOBA has organised ten International Congress meetings and eighteen International Symposia in venues located in Europe, Canada, Jamaica, Brazil, India and recently in China. It was proposed at the time of the ICSOBA symposium in China in November 2010 that an International Seminar on bauxite residue (red mud) be organized in view of the recent dam failure in Hungary.

Alumina refineries world over presently generate more than 100 million tons of red mud per annum, which is likely to increase with the setting up of new production facilities and decreasing ore quality. Less than 5% of red mud is being utilized in the world with the remainder disposed in ponds.

# **Aims and Objectives**

- •To review the present status of bauxite residue characterisation, handling, disposal, storage, treatment and utilization in various alumina refineries of the world.
- •To discuss problems related to environment and safety considerations for safe disposal and storage of mud.
- •To highlight the best options for mud handling, storage, treatment / utilization etc. for existing and future Greenfield alumina refineries.
- •To discuss promising research developments in the field of safe storage of red mud and its treatment / utilization.

We invite you, dear colleagues, to participate and present papers in the International Seminar "ICSOBA -2011" on the topic of your interest or field of work, from amongst the wide-ranging objectives of the seminar mentioned above. The Seminar will provide an excellent opportunity to meet and interact with International Experts, Scientists, Engineers, Entrepreneurs and Representatives of alumina industries, companies dealing with red mud, R&D institutes and end users world over.

A Technical Excursions will be arranged to the rehabilitated red mud storage areas of HINDALCO in Belgaum, India.
